This notice is given pursuant to clause  7.6  7.7  8.1 of the Agency Agreement and clause  6.1  6.2  6.3  6.4  7.1  9.13 of the Trust Deed and in respect of the  Adjustment of Conversion Price  Closure of Register of Shareholders  Early Redemption. The capitalized terms herein without definitions shall have the same meaning given to it under the Agency Agreement or the Terms and Conditions.

Please be informed that the Conversion Price will be adjusted as follows:
