**Information Notice**

Reference is hereby made to the abovementioned Notes. Capitalised terms used herein but not defined shall have the meanings ascribed in the Trust Deed dated 20 June 2007 relating to the £15,100,000 8 per cent. Series A Secured Convertible Notes due 2012 as amended and supplemented from time to time (the “**Trust Deed**”) made between BNY Mellon Corporate Trustee Services Limited (formerly BNY Corporate Trustee Services Limited) and Radicle Projects plc (the “**Issuer**”).

Brett Lord, Stephen Parbery and Craig Crosbie of PPB Pty Ltd acting as joint and several administrators and subsequently liquidators of Radicle Projects Pty Ltd. (in liquidation) (the “**Liquidators**”), have been engaged in the sale of certain assets of Radicle Projects Pty Ltd. charged to the Trustee for the benefit of the Trustee and the Noteholders.

Reference is made to previous notices to Noteholders dated 13 April 2011 notifying Noteholders that an adjourned meeting of Holders was taking place on 27 April 2011, dated 27 April 2011 notifying Noteholders that an extraordinary resolution was passed at the adjourned meeting on 27 April 2011 and dated 8 March 2012 notifying Noteholders of an interim payment of liquidation proceeds.

**Application of Final Repayment Amount:** the Trustee received the sum of AUD85,140.85 (the “**Final Repayment Amount**”) from the Liquidators of Radicle Projects Pty Ltd (in liquidation) as the final payment of liquidation proceeds.

**APPLICATION OF FINAL REPAYMENT AMOUNT**

The Final Repayment Amount shall be paid to the Noteholders *pari passu* and rateably in accordance with Clause 9 of the Trust Deed, less any amounts ranking prior thereto and deductible by the Trustee pursuant to that Clause and calculated as follows:

**Cancellation of Notes:** following the payment of the Final Repayment Amount, the Trustee will direct the Principal Paying and Conversion Agent to advise the relevant Clearing Systems to cancel the Notes in accordance with Condition 7(f) of the Notes (as amended by a meeting of Holders on 27 April 2011).
