Capitalised terms used and not defined in this notice shall bear the meanings given to them in the terms and conditions of the Loan Notes (the "Conditions").

Pursuant to the Conditions and the agency agreement, dated 13 June 2018, relating to the Loan Notes between Swiss Re Ltd, as Issuer, The Bank of New York Mellon SA/NV, Luxembourg, as Fiscal Agent, and The Bank of New York Mellon SA/NV, Luxembourg, as Registrar, Swiss Re Ltd (the "Issuer"), hereby notifies Loan Noteholders that as a result of the Cash Dividend of CHF 6.21554 per Share payable on 18 April 2024 to Shareholders of record on 17 April 2024, the Calculation Agent has determined that, effective 16 April 2024:

- the Exchange Price is adjusted to U.S.\$ 90.4313 (previously U.S.\$ 94.1610) pursuant to Condition 4.5(a)(ii) of the Conditions;
- the Exchange Ratio (pursuant to the definition thereof in the Conditions) based on such adjusted Exchange Price as aforesaid is 2,211.6236 (previously 2,124.0216); and
- the Share Price Floor is adjusted to U.S.\$ 34.7812 (previously U.S.\$ 36.2157) pursuant to Condition 4.5(a)(ii) of the Conditions.
