*Capitalised terms used in this Notice that are not otherwise defined shall have the meanings given in the trust deed dated 9 December 2019, as modified by the first supplemental trust deed dated 13 July 2022, which constitutes the 2025 Bonds (the **2025 Bonds Trust Deed**) and the trust deed dated 18 June 2020, as modified by the first supplemental trust deed dated 13 July 2022, which constitutes the 2027 Bonds (the **2027 Bonds Trust Deed** and, together with the 2025 Bonds Trust Deed, the **Trust Deeds**).*

**NOTICE IS HEREBY GIVEN** that each of Ocado Intelligent Automation Limited and Ocado Solutions Canada Inc. (together, the **New Guarantors**) has acceded as an Additional Guarantor in respect of each Series pursuant to a Second Supplemental Trust Deed (as defined below) in respect of the relevant Series with effect on and from 28 November 2023 (such accession of the New Guarantors, the **Accession**).

To implement the Accession, Ocado Group, the New Guarantors and the other relevant parties thereto have entered into:

- (i) a second supplemental trust deed dated 28 November 2023 that supplements the 2025 Bonds Trust Deed;
- (ii) a second supplemental trust deed dated 28 November 2023 that supplements the 2027 Bonds Trust Deed;
- (iii) a second supplemental paying, transfer and conversion agency agreement dated 28 November 2023 that supplements the paying, transfer and conversion agency agreement dated 9 December 2019 and the first supplemental paying, transfer and conversion agency agreement dated 13 July 2022 in respect of the 2025 Bonds; and
- (iv) a second supplemental paying, transfer and conversion agency agreement dated 28 November 2023 that supplements the paying, transfer and conversion agency agreement dated 18 June 2020 and the first supplemental paying, transfer and conversion agency agreement dated 13 July 2022 in respect of the 2027 Bonds.

In this Notice, the second supplemental trust deeds described in (i) and (ii) above are referred to as the **Second Supplemental Trust Deeds** and the second supplemental paying, transfer and conversion agency agreements described in (iii) and (iv) above are referred to as the **Second Supplemental Agency Agreements**.
