On 12th April 2023, the Issuer received notice from Mediobanca – Banca di Credito Finanziario S.p.A. ("**Mediobanca**") that following the General Meeting held on 31st March 2023, that:

- "the Company's Adjusted Consolidated Profits for the year 2022 are €5,916,802,542.52; and
- the total amount of all Distributions approved as dividend referred to the Financial Year 2022 by the above mentioned General Meeting that could be paid by UniCredit in cash (and therefore represent a cash dividend) on any class of its share capital is €1,906,562,000.00; and
- the aggregate of all Quarterly Amounts paid on any preceding Payment Date in the Relevant Period is € 51,143,412.41; and
- the Maximum Amount for the relevant period is €3,959,097,130.11"

On the basis of the above information and in accordance with the Agreement for the creation of a right of *usufrutto* between UniCredit S.p.A. and Mediobanca, dated 23rd February 2009 and subsequently amended on 13 December 2011 and on 15 May 2020 (*Contratto per la Costituzione di Usufrutto*, the "**Agreement**"), UniCredit notified to Mediobanca that:

- "the condition for mandatory payment under the first paragraph of Article 4.5 is met (to the extent of the Maximum Amount);
- In respect of the Payment Date falling on August 25th 2023, the Quarterly Amounts, equal to €59,563,890.19 will be paid in full."
