- (d) Notwithstanding the completion and delivery to the Corporation of this declaration by the proposed registered owner or agent, such registered owner of the Shares shall, if required by the Corporation, cooperate with the Corporation in obtaining the name and address of each *beneficial owner* of such Shares and a separate declaration in form satisfactory to the Corporation, from and in respect of each *beneficial owner* of such Shares.
