Important Information for CDS Participants

Ordinary Shares of Tombador that are held on the Issuer Sponsored subregister must be converted to the CHESSE subregister before they can be traded on the ASX.

It is essential that the information you provide has been confirmed by your applicable CHESSE custodian and that they are informed well in advance of time that they will receive a credit to the account.

If Computershare does not receive the completed form by 9:00am Eastern time on the Effective Date of the Plan of Arrangement, an Issuer Sponsored Statement will be issued in the name of the CDS Participant and mailed by Automic Group to the address as shown on the list of Participants to be provided by CDS shortly after the Effective Date of the Plan of Arrangement. Such Effective Date will be announced by GoviEx and Tombador following the meeting of GoviEx securityholders on October 24, 2025.
