We are delivering this letter in connection with the purchase of common shares (the "**Common Shares**") of CARDINAL ENERGY LTD., a corporation incorporated under the laws of the Province of Alberta (the "**Corporation**") upon the exercise of warrants of the Corporation ("**Warrants**"), issued under the warrant indenture dated as of January 3, 2025 between the Corporation and Odyssey Trust Company.

- (d) we are not acquiring the Common Shares with a view to distribution thereof or with any present intention of offering or selling any of the Common Shares, except (A) to the Corporation, (B) outside the United States in accordance with Rule 904 under the U.S. Securities Act or (C) inside the United States in accordance with Rule 144 under the U.S. Securities Act, if applicable, and in compliance with applicable state securities laws. For greater certainty, we acknowledge and agree that no resale may be made within the United States pursuant to Rule 144A or Rule 144 under the U.S. Securities Act or otherwise, even if any such exemption from the registration requirements of the U.S. Securities Act would otherwise be available; we acknowledge that we have had access to such financial and other information as we deem necessary in connection with our decision to exercise the

Warrants and purchase the Common Shares; and

(e) we acknowledge that we are not purchasing the Common Shares as a result of any general solicitation or general advertising, including advertisements, articles, notices or other communications published in any newspaper, magazine or similar media or broadcast over radio, television, or any seminar or meeting whose attendees have been invited by general solicitation or general advertising.

We understand that the Common Shares are being offered in a transaction not involving any public offering within the United States within the meaning of the U.S. Securities Act and that the Common Shares have not been and will not be registered under the U.S. Securities Act. We further understand that any Common Shares acquired by us will be in the form of definitive physical certificates and that such certificates will bear a legend reflecting the fact that we will not offer, sell or otherwise transfer any of the Common Shares, directly or indirectly, unless (i) the sale is to the Corporation; (ii) the sale is made outside the United States in compliance with the requirements of Rule 904 of Regulation S under the U.S. Securities Act; or (iii) the sale is made in the United States (A) pursuant to an exemption from registration under the U.S. Securities Act provided by Rule 144 thereunder, if available, and in compliance with any applicable state securities laws or (B) pursuant to a transaction that does not require registration under the U.S. Securities Act or applicable state securities laws, and the seller has furnished to the Corporation an opinion to such effect from counsel of recognized standing reasonably satisfactory to the Corporation prior to such offer, sale or transfer. For greater certainty, we acknowledge and agree that no resale may be made within the United States pursuant to Rule 144A or Rule 144 under the U.S. Securities Act or otherwise, even if any such exemption from the registration requirements of the U.S. Securities Act would otherwise be available.

We acknowledge that you will rely upon our confirmations, acknowledgements and agreements set forth herein, and we agree to notify you promptly in writing if any of our representations or warranties herein ceases to be accurate or complete.
